

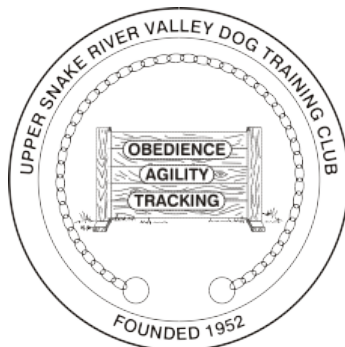

### ENTRY INFORMATION

Entries close at 9:00 p.m., Wednesday, July 26, 2017. Fees must accompany entries. All checks and money orders for Obedience and Rally Trials are to be made payable to **USRVDTC**, in U.S. FUNDS, and mailed or hand carried to Suzanne J Belger, Trial Secretary, 994 Lowell Drive, Idaho Falls, ID 83402. No entry will be accepted, canceled, or substituted except as provided in Chapter 11, Sections 3-7, of the Rules Applying to Dog Shows. Facilities are NOT available for facsimile and/or credit card entries. Upper Snake River Valley Dog Training Club is NOT accepting online entries. Please mail entries so that they arrive on or before closing.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. The club and/or its Trial Secretary assumes no responsibility for wrong or incomplete information given by the owner or the owner's agent or for entering the dog in a class in which the dog is not eligible to compete. THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.

Entries not on official AKC entry forms or photocopies of entry forms without the agreement and rules on the reverse side of the official AKC entry form are invalid.

Illegible or incomplete entries will not be processed and will be returned to the exhibitor. Entries not accompanied by the correct fees or a returned check do not constitute a valid entry. The Trial Secretary will add a \$25.00 collection fee to the amount of each returned check. Those that have checks returned for NSF will be on a cash only basis for all future trials.

Mixed Breed Entries. Mixed Breed dogs entering classes for Obedience and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

### REFUNDS

Bitches in season are not permitted to compete in obedience or rally trials. As such, the club will refund entry fees for bitches unable to compete for this reason upon presentation of a veterinarian certificate. This certificate must be presented to the Trial Secretary no later than one-half hour prior to the start of the first class of the day of the trial. The club will retain a processing fee of \$5.00 per entry per trial.

Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Trial Committee, or because the dog is ineligible to compete due to being entered incorrectly.

No entry fees will be refunded if the Trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other causes beyond the control of the Trial Committee.

Refunds for cancellations due to judge change, overpayment of entries or cancellations made prior to closing date will be mailed to said Exhibitor or Agent after the trials.

USRVDTC may decline any entries for cause and may refuse to receive, or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against USRVDTTC or officials thereof.

### **TRANSFERS**

A transfer (formerly a move-up) may be requested from the trial secretary if, according to the owner's records, the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers are to comply with Chapter 1, Section 16 of the Obedience Regulations.

### **DOGS ELIGIBLE TO ENTER**

Per AKC Rules and Regulations: This trial is open to all dogs over the age of 6 months that are registered with the American Kennel Club or are registerable breeds that have obtained an AKC PAL/ILP number. Dogs born after February 11, 2017 for events 2017013904 and 2017013905, February 12, 2017 for events 2017013906 and 2017013907, or February 13, 2017 for events 2017013908 and 2017013909 are not eligible for entry. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under six months of age are strictly prohibited from the trial grounds. Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form and the trial-giving club is offering the optional mixed breed classes.

## JUDGING INFORMATION

Confirmations and judging schedules will be emailed unless otherwise requested. An entry acknowledgment along with a judging schedule will be emailed to the address on the entry after entries close. (If you wish your Agent to receive an acknowledgment of your entry and/or judging schedule, please submit request with entry and Agent's correct address for this courtesy.) Should Exhibitor NOT receive an acknowledgment within a reasonable time, PLEASE notify the Trial Secretary by telephone at (208) 521-8872 or [desertmtnmalinois@gmail.com](mailto:desertmtnmalinois@gmail.com).

Check In will start at 8:00 a.m. Judges briefing will be approximately 10 minutes prior to the start of each class, where required. Judging will start at 8:30 am.

PLEASE CONSULT THE JUDGING PROGRAM for time of judging. JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when it is to be judged. The USRVDTTC Trial Secretary has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought to the ring when required.

Consult AKC's Obedience Regulations and Rally Regulations for specific class information and detail. These trials will follow these rules and regulations.

Rally Ring will be 40' x 60'.

### **NOTICE TO EXHIBITORS**

#### **SAFETY, BEHAVIOR and LIABILITY**

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all exercises and obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Upper Snake River Valley Dog Training Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Upper Snake River Valley Dog Training Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Upper Snake River Valley Dog Training Club or any official thereof. The Upper Snake River Valley Dog Training Club will not be responsible for the loss of/or damage to any dog entered and exhibited, whether the result of accident or other cause. It is distinctly understood that every dog at this trial is under the care, custody, and control of its owner or handler at all times. The Upper Snake River Valley Dog Training Club officers, board members, and the Trial Secretary assume no responsibility for any loss, damage, or injury sustained by the exhibitors, their dogs, or property.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Crating space will be available after 6:30 p.m. on Thursday, August 10, 2017. Crates may be left overnight. The Upper Snake River Valley Dog Training Club will not be responsible for any lost or damaged items left at the show site.

There will be no food vendor on site. There are several restaurants and fast food establishments nearby. Lunch, snacks, and water, will be provided for those working two or more classes.

This club does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.

**THERE SHALL BE NO drilling, or intensive or corrective training on the show grounds or premises. Any training or warm up must comply with Chapter 2, Section 26 of the Obedience Regulations.**

**ADDITIONAL TRIAL RULES.**

- No alcoholic beverages permitted in the park.
- No parking on the grass.
- There is NO overnight parking allowed at the trial site.
- Areas marked as “no parking” will be strictly enforced.
- Idaho Falls, ID has a leash law. All dogs must be on leash at all times when on trial grounds except when competing in the ring or in crate.
