Hope competed in Scent work where she earned her Excellent Exterior title and also Q'd in Containers and Buried on Friday.

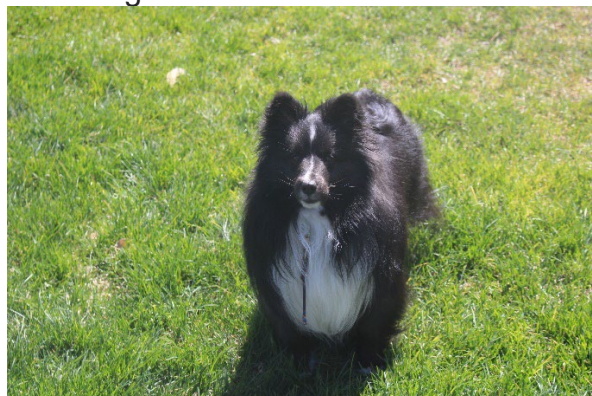
Belle in Obedience had a good effort on Friday but just missed her sit signal. Saturday and Sunday, She finally put it all together for 2 Q's in Open A.

Agility – Table is not going to be in the trial courses any longer. As of July 1, 2024, the American Kennel Club (AKC) will allow For Exhibition Only (FEO) in all agility classes, including Premier, Standard, and Jumpers with Weaves. Previously, FEO was only permitted in the Time 2 Beat, Fast, and ISC classes at the club's discretion.
